Introducing the Fly-in Fly-out Parking Program (*also known as the Adelaide Airport Nominated Employee Parking Program*). The program provides the opportunity for FIFO Employees of participating Organisations to access substantial cost savings on airport parking whilst reducing payroll tax liability for the Employer.

1. Benefits to Employers.

- Complimentary Program Onboarding plus zero ongoing costs*
- Payroll Tax Savings[^]
- Opportunity to reduce FBT liability
- Enhanced value proposition for employees
- Streamlined invoicing & reporting: Monthly statements supplied by Adelaide Airport

2. Benefits to Employees.

- Heavily discounted car park rates[^]
- Priority parking space availability
- Seamless car park entry and exit: Individual Adelaide Airport access cards will be provided
- No pre-booking required
- No payment or tax invoice collection required on exit

[^] The Income tax savings the Employer receives from the GST component will be passed onto the Employee. For example, employees with a \$0.37 marginal tax rate will receive a 37% discount on the cost of Airport Parking.

How it works:

The Parking Program has been designed to simplify the way frequent FIFO Employees travel through the airport as well as benefit the Employer by reducing payroll tax liability.

- » Employers will be provided Adelaide Airport parking access cards for distribution to employees participating in the program.
- » Members of the program will use their parking access card to enter and exit the nominated Adelaide Airport Car Park. Card holders won't be charged on exit.
- » Adelaide Airport will provide a Parking Activity Statement each month to the Employer. This will calculate the usage of each access card holder.
- » The Employer may apply the accrued parking cost per access card holder as a pre-tax adjustment to the Employee's salary payment. This results in a significant parking cost saving for each access card holder whilst reducing the payroll tax liability for the Employer.
- » The employer may reclaim the GST component from eligible parking costs as an Input Tax Credit and pass this onto the employee.

Calculate your savings



By salary sacrificing Airport Parking, employees and members of the program are eligible to receive significant savings compared to 'drive-up' and 'online' parking rates. Refer to the table below for potential savings based on a pre-tax monthly salary of \$8000 and two parking stays per month in the Long Term Car Park.*

Example Monthly Savings Comparison Table

Total Monthly Savings	-	\$44*	\$97*

*Savings after-tax are relative to the employees marginal tax rate. Monthly savings based on 2 x 7 day stays in the Long Term Car Park.
